

**Canonsburg Borough Council Meeting**  
**Monday, December 14, 2009**  
**7 p.m.**

The meeting was preceded by a ceremonial deed transfer of property at Jefferson Avenue and Murdock Street from the Washington County Redevelopment Authority to the Greater Canonsburg Library Board. President Dan Caruso Jr. presented the deed to Library Board President Susan Poore.

Meeting was convened at 7 p.m. by President Dan Caruso Jr.

**Guests/Public Comments**

- Library Board President Susan Poore thanked council for the deed transfer and announced that groundbreaking for the new library would be Friday, January 8, 2010.
- Washington County Redevelopment Authority representative Kerry Fox gave an update on items concerning Washington County Redevelopment Authority, and reminded council that the deed transfer to the library would have to be formally approved by Washington County Commissioners later this month.
- Mayor Colaizzo received a plaque from the police force for his 10 years of service as mayor. Sgt. Cross made the presentation.
- Canonsburg Fireman Dave Rhome invited all councilmen to the Firemen's Christmas Party Monday, Dec. 21 at 7 p.m.

**Executive Session:** An executive session regarding personnel (non-uniform contract) was called by the council president.

**Mayor's Report:** Mayor Colaizzo announced that he, the incoming mayor (David Rhome), Police Chief R.T. Bell and the police force had devised a 12-hour shift schedule that would save the borough overtime expenses and benefit the police force in various ways, including packaging more consecutive time off for police. The three-man shifts would be 7 a.m. to 7 p.m. and 7 p.m. to 7 a.m. effective January 1, 2010. An 8-hour shift

would be inserted into the schedule to keep the two-week pay period at 80 hours.
