F. Planning Commission Meeting of January 8, 2009

1. Reorganization

The Planning Commission kept the same officers as they had the previous year: John DeFilippo – Chairman, Joseph Milioto – Vice Chairman, and Dominick Calabro – Secretary.

2. Rezoning Request for 203 Adams Avenue (corner of East College and Adams) and 207 Adams Avenue (Approval was recommended by the Planning Commission.)

Mr. Frank Iannarelli, of T.I.P. Enterprises, explained to Council what they are proposing: To put in a soft-serve ice cream type of establishment at 203 Adams Avenue where a service station had been previously. The area is zoned Commercial with the exception of two properties: 203 Adams Avenue and 207 Adams Avenue (which is the location of an existing antique shop).

Mr. Williams moved to advertise for the rezoning of 203 Adams Avenue and 207 Adams Avenue from R-3 to C-3.

Mrs. Popp seconded the motion.
