A presentation to Council for approval of a K-9 officer to the Police Department. He introduced the police officers: Sgt. Alex Coghill and Matt Tharp, who would be the handler of the K-9. A movie to be shown tonight shows that the K-9's initial impact would be on the drug world and things such as crowd control.

Chief Bell stated that he gave Mr. Russo a pamphlet they made up that explains the program. (If Council approves this, more will be made up and given out around the community.) He explained that the Police Department is hoping to get funding for the dog through donations through businesses. Sgt. Coghill gave a power point presentation of what a K-9 officer can do, the necessary equipment needed, costs, means of funding, and liability. Training for Officer Tharp and his dog should begin April 8, 2013.

Council members were given an opportunity to ask questions.

Officer Tharp explained that this involved a lot of research, which took some time.
