V. PUBLIC COMMENTS:

A. Mr. Justin Smith, of 318 Munnell Street, stated that one of his neighbors came before Council a couple months ago with a petition about the condition of the road. Mr. Smith informed Council that since that time the road has gotten much worse. There are large sections, some as wide as three feet and ten to twelve feet long, that are completely deteriorating. The garbage truck coming down has a hard time stopping and breaks the road up. Mr. Smith stated that this has become a safety issue.

Mr. Sharkady has seen the road and confirmed that it is very bad.

Mr. Smith said he took pictures this morning but was unable to get them developed. However, he had them on his phone and offered to let Council view them.

Mr. Hazlett stated that the Public Works Director talked to him last week about bringing this up tonight. They are having

a hard time plowing because they can't figure out where the road is.

Discussion was held pertaining to this matter, qualifying the Street, and possible funding avenues.

B. Ms. Elizabeth Francis, of 306 Forest Drive (in Apple Hill), stated that it has come to their attention that there are individuals in their plan that are interested in opening up the division that separates at the end of Forest Drive into the Alto Piano/Network Drive area.

Ms. Francis stated that she moved to this particular community in Canonsburg from Pittsburgh seven years ago. This was and continues to be an ideal location to raise children with an excellent school system, quiet and safe neighborhood streets, with limited traffic.

She continued by saying that these neighborhoods are for families, not for shortcuts for commuters between Southpointe and Route 980 as a means of convenience.

Ms. Francis stressed the fact that the proposed connection would jeopardize the way of life the residents of Apple Hill and Alto Piano have come to value. She also stated that the safety of their children, residents, and pets is paramount. The roads are not equipped to handle such an increase in the volume of traffic. There are no streetlights or sidewalks for safe pedestrian travel in Apple Hill.

Other concerns were the degrading of roads, repairs would likely increase taxes, and excess traffic would impact the resale value of the homes and decrease the desirability to live in the neighborhood.

Ms. Francis ended by requesting that Council vote not to connect Forest Drive in Apple Hill and Network Drive in Alto Piano and instead opt for a permanent green area. She presented a petition with 157 signatures supporting her request. Mr. Bevec stated that this is the first Council has heard of this.

- Cecil would have to approach the Borough if that were to happen. Ms. Francis informed Mr. Bevec that there is a second petition with 47 signatures in favor of the connection.
 - C. Mr. Chad Moore, of 307 Forest Drive, addressed the same subject as in Item A. He added that with the substantial increase in traffic flow that would be coming from 980 to Southpointe, Southpointe to 980, 980 as a shortcut to 79 North, there will be additional wear and tear on the streets. The additional construction traffic that's going to be needed to finish the Alto Piano Plan and people coming from the north to finish the Apple Hill Plan will be additional wear and tear on the streets. Additional traffic will mean additional police patrols for speeding and traffic violations. Mr. Moore said that as he stated in 2010, these residents who will be using this road are predominantly not Canonsburg residents, and our tax dollars will be used to pay to keep those roads maintained and patrolled. He asked that Council consider this from a tax standpoint for maintaining the roads and asked that Council vote unanimously to permanently close Forest Drive – dead end.
 - D. Mr. Kevin Kline, of 310 Forest Drive, reinforced the comments made by the other Apple Hill residents who spoke tonight.
 - Mr. Bevec referred this matter to the Engineer.
 - Mr. Treschow stated that there must first be a request from someone wanting to open it. Nothing has been presented yet.
 - Mr. Moore asked if he could make a request to permanently close the road and never open it.
 - Mr. Bevec informed Mr. Moore that he can make that request, but he doesn't know if it can be honored right now, as there is a legal issue and an engineering issue that would need addressed.
 - Mr. Bevec stated that the Solicitor and Engineer will look into this.
 - Mr. Treschow added that Cecil Township would also have to agree with this.
