Denise asked if the amount would be \$52,000.00 Mr. Russo advised \$49,000.00 and we already approved \$30,000.00. Mr. Russo then explained the total is \$114,000.00 which is \$81,000.00 plus the lights at \$33,000.00 so an additional \$50,000.00 above the \$30,000.00. Mr. Chandler then stated this is a huge difference from before. Mr. Russo advised the original bid from Lighthouse Electric did not include running new ground wire so when KLH took it over because it needed to be bid, they required all new ground wire to be installed.
