PUBLIC COMMENTS:

Mike Roman, 426 Chartiers Ave – Borough Council and the mayor have received in their packets an invitation to the invite only open house at the Robert's Stone House Restoration. I just wanted to mention to the mayor and also to Brian that included with that invite is the closing of a street, Orchard Ave for approximately five (5) or six (6) hours to set up some tents for food and for some other beverages. So, is there anything that we need to do to satisfy

the borough just to close a street? The street is Orchard Ave, located on the upper side of N. Central Ave., to the right of The Roberts House, where the two (2) parking lots are. We are also going to notify the residents who live behind that there is access to their homes from the upper lot.

Councilman Yorke – I am one of the representatives to the sewer authority, and when this presentation came about I was one of the ones last, in fact I was filled in on the way in from different people calling me up knowing more about what was going on than I did. So, I took it upon myself to learn. I went out to probably one of the most qualified places to get it and seen Mrs. Graham out there in the city of Cleveland. More or less, she took me by the hand, filled me in on a lot of areas that were discovered. I wish with my gut feeling I felt good about this, and that's where I'm coming from. My gut feeling, I don't feel good about that. I'm telling my council members and I'm telling the public it's more of a gut feeling. Moving this quick on this much money is not the way to go. Currently working with two (2) of the buildings that are for sale in town now have contingent contracts in place. The Citizen's Bank Building and also the Cigar Shop. So, working with those folks and we will see how it all pans out. She went on to report that she is working with Erik Mark on an open space he has open in town to bring in a short-term tenant as a pop-up establishment for the holiday season, so we should have that finalized by the end of the week. She continued to report that she has a viewing at Tri-State Antiques on November 10, 2023, with some people that are interested in that building and she will keep everyone posted. With regard to events, the event calendar coming

up is the Halloween Crawl, with the children hosted by the Chamber of Commerce, on Saturday, October 28, 2023. The holiday schedule with the merchants and the bar owners, for the Jingle Bar Hop will be November 25, 2023, the Old-Fashioned Christmas Celebration is December 1st and 2nd, and the Merry Merchant Christmas Crawl will be December 9th. Finally, she and Eric are working with WQED on Fred Rogers Be My Neighbor Day that will be scheduled for February
