PUBLIC COMMENTS:

Donna Stutts, 24 Munnell St – I know there is a lot going on about the parking. First of all, I support it and I think everybody ought to pay. You come by those lots at night and they are full of people at the bars, they need to pay. My second thing is I am a handicapped person, and I can't get to very many places. I can't go to any of the activities downtown because there is no place to park where we can both walk to the activity. I'm asking the board before we start the new parking lot, to make some type of arrangement or whatever it is, a contract or whatever, to provide spaces just for handicapped people to attend the events, I, personally

would like to go see these things. My next question is, does South Central have a sink hole underneath of it?

Is there someone that manages the website that could possibly provide assistance? I always get a message "You can't open up this site. There is no app associated". You have to go to default programming.

Melissa Graff – Do you type in just canonsburgboro.com or do you type in www.canonsburgboro.com?

Dennis Smiddle – I pull up the website

Melissa Graff – Right. But if you just type canonsburgboro.com, it will not come up, you have to type www.canonsburgboro.com

Rich Russo – Are you talking about our website? I just typed Canonsburg on my phone, and it came up. You don't need the www

Melissa Graff – sometimes you do. I know I tried it and sometimes you do.

Mr. Chandler – So, if you need an agenda printed out, the office can print one out for you. It could be something on your end, your device or something like that that isn't allowing you to open that up

Female Speaker – I have the same problem as Mr. Smiddle, it goes to default, and you can't open it up and you don't know which settings to go to.

Joe Dalfonso – Whenever you advertise a legal ad, it goes to the legal ad section, and that's every paper across the Commonwealth and there's nothing the borough can do to do that.

A.J. Williams, Chamber of Commerce – This week we are in the middle of a career week between Canon-Mac and Chartiers. We have 6 periods per day where we are sending members of the workforce, the chamber to the schools for a period to cover different topics. May 19, we have a lunch and learn at ARC Headquarters and the topic will be Technology in the Workplace. The farmer's market starts June 7th and that's at St. Pat's. It has grown again this year. As of March 20th, we had 15 vendors there were 20 pending applications waiting to be received. So, we are looking at between 20 and 30 vendors each week at the farmer's

market. It's between 3 and 7 on Wednesdays at St. Pat's. June 23, we are doing an after-hours mixer at J&D Cellars. June 25th will be the return of Alley Way Saturday, the last Saturday in June, July, and August. July 21 there is a pool party and then we end our summer with Oktoberfest. Switching hats now, for anyone that doesn't know the Saturday of Oktoberfest there will be a 5k that morning. It is the Tunnel to Towers 5k, it's a national organization where they come in and if a veteran or first responder needs something, they provide for that veteran and/or first responder. Last year it was held in Southpointe, and they had 400 runners and our goal this year is 1000 runners. Last year they raised \$1500.00, and our goal is \$100,000.00. The route is being mapped out right now by Harshman Assoc. so as soon as we have that we will get it to everybody. It has been coordinated with the mayor and the police department. The other goal is to have representation from every emergency service within the county, so we are now making this a county-wide event and trying to get support from everyone in the county. The last thing I have is the parking. The chamber has been in discussion, and we have talked to Lisa about this, but we are interested in partnering with the borough to purchase an x number of hours of parking per month. What we will do with that is and Lisa you can be confirm this, we can be given a code to enter into the kiosk and we will purchase the codes and then chamber members within downtown, that will be part of being a member of the chamber that we will allocate x number of hours of parking for the customer base. We can definitely talk about that more. Hopefully, it will take away some of the burden the businesses are feeling but won't take away from the parking revenue.

Mr. Russo – So, it sounds like an old school token system which wouldn't be for owners but for customers
